At this stage, we know that applications won't open till much later this year.

We also know that the cost of the event will not rise from AJ2019, and it may even fall. And we know that with a changing world around us, some of the things we've taken for granted at previous Jamborees, will be re-considered for 2022.

What hasn't changed is our ambition to hold another extraordinary adventure that all participants will never forget!

And we already have a brand new logo, which has been specially designed to reflect our unique launch plans for NSW.

Once we have our required sign-offs, we will officially launch AJ2022 to parents and youth with a range of communications, including a newsletter, website update and social media posts.

When we are able to confirm the date for applications to open, we'll be sure to provide you with an Information Pack and presentation, which you can use to run information sessions in your local area.



Scouts Australia NSW is committed to operating as a child safe organisation and implementing child safe policies and practices in accordance with the elements of a child safe institution outlined by the Royal Commission into Institutional Responses to Child Sexual Abuse report entitled Creating Child Safe Institutions.

All suspicions, concerns or allegations about criminal matters or child protection matters should be reported directly to the Chief Commissioner, the Deputy Chief Commissioner (Youth Safety, Compliance and Support), the CEO or the Child Protection Officer at the NSW State Office. Imminent Danger

If a young person is in imminent danger, the matter should be reported directly and immediately to NSW Police on 131 444. Where a report is made to the police, you should also subsequently notify the NSW State Office.
